Our performance during the third quarter and the nine-month period of 2025 continued its growth trajectory, driven by an increase in the number of members and the improved operational performance of our existing clubs, in addition to the contribution from the new clubs opened this year.

This was clearly reflected in a 14.1% increase in revenues compared to the same ninemonth period of the previous year, demonstrating the strength of our business model and the success of our new brand identity strategy.

We continue to expand our network of clubs, which has now reached 59 clubs across cities in the Kingdom, with 16 projects currently under development at various stages.

The results achieved this quarter reaffirm the success of our new club identity, which enhances our members' experience, expands our customer base, and continues to create sustainable value for our shareholders.

Segmental Performance



(Body Masters) Men's Clubs

The men's clubs segment (Body Masters) remained the Company's largest revenue contributor, supported by steady growth in memberships and strategic network expansion. As of 30/9/2025, the number of active men members reached 118,967 members, with a 26.9% increase compared to the same period last year.

This member growth contributed to a 27.2% increase in revenue from men's clubs during the third quarter of 2025. And a 14.1% increase during the nine months of 2025. The positive trend reflects both growing demand and the strength of the Body Masters brand.

The Company continues to invest in expanding its men's club network, with 42 active clubs as of the end of the quarter, with 8 additional Body Masters' clubs in the pipeline.

(Body Motions) Women's Clubs

The women's clubs segment (Body Motions) continues to be a key growth driver for the Company. Revenue from women's clubs grew by 21.6% in Q3 2025 compared to the same quarter last year and an increase of 13.0% compared to the nine-months last year, a performance closely tied to the surge in active female members, which rose by 35.5% year-over-year to 39,482 members.

This strong demand is the result of expanding social trends toward wellness and increased participation by women in fitness activities across the Kingdom. The Company responded to this demand with the opening of one new women's clubs during the third quarter, that bringing the total number of active female clubs to 17 as of 30/9/2025, with 8 additional Body Motions' clubs in the pipeline.

(Body Experts) The Fitness solutions Segment

The fitness solutions segment (Body Experts) delivered revenues growth by 17.7% in nine months of 2025 compared to the same period in 2024 and decreasing during the third quarter of the year compared to the same period last year, due to the nature of the construction work of the segment.

The Company continues to enhance this segment through initiatives with several entities, supporting higher margins and diversified income.
